

HGS Workshop Knowledge Management or Management of Ignorance?

CONTENT

In the permanently increasing flood of information knowledge management seems to be the appropriate lifebelt concerning research and scholarship. But how could knowledge management be defined and implemented? Is knowledge management our best approach to survive facing the amount of published materials? Or does knowledge management indicate the state of ignorance affecting all of us as members of the information society? Knowledge management is rooted in classifying and systematizing knowledge. Knowledge management includes methods and strategies to identify or to search for reliable knowledge. Finally knowledge management is a necessary requirement to organize the running research work and the publication of research results. The workshop will discuss knowledge management from the main idea, the background and the development of different perspectives.

LECTURERS

Andreas Degkwitz is chief librarian of the Humboldt University of Berlin since September 2011. In his former positions he was the chief information officer of the Brandenburg Technical University of Cottbus and acting director of the library of Potsdam University. Previously he has been junior consultant in the department for libraries and information systems of the German Research Association (DFG). Since many years his interests are focusing on the digital turn of media and scholarly communication.

Susanne Haaf studied German Philology and Computational Linguistics (M. A.) at the Universities of Heidelberg and Zurich. From 2007 to 2010 she worked as a research assistant within the project »Martin Bucers Deutsche Schriften« at the Heidelberg Academy of Sciences and Humanities. Currently, she is a research assistant within the projects »Deutsches Textarchiv« (since 2010; www.deutschestextarchiv.de) and »CLARIN-D« (since 2012; www.clarin-d.de) at the Berlin-Brandenburg Academy of Sciences and Humanities. Furthermore, she has been teaching courses at the Universities of Berlin (FU) and Regensburg. Her work focuses on editorial studies, the constitution and maintenance of corpora, as well as guidelines for the TEI encoding of large heterogeneous text collections.

Since 1978 Walther Ch. Zimmerli has been professor of philosophy at various universities both in Germany and abroad; from 1999 to 2013 he was member of the top management of a multinational company and president of Brandenburg Technical University (BTU) Cottbus; since November 2013 he is senior endowed professor of Mind and Technology at Humboldt University Berlin. He has been publishing extensively on topics related to Philosophy of Technology, Artificial Intelligence and the Network Society.

Günther Görz has been professor of Computer Science (Artificial Intelligence) at the University of Erlangen-Nuremberg. Since October 2012 he leads a research group on Digital Humanities. He is also a visiting scholar at the Max Planck Institute for the History of Science. For his sabbatical stay in 2010/2011 the general subject of cooperation was "Semantic Modeling and Knowledge Representation for Scientific Object Documentation and Digital Editions. In his research, he focuses on AppliedLogic (knowledge representation and reasoning) and natural language processing.

Christian Thomas has studied German Literature and Philosophy at Berlin's Humboldt-University. Since 2010 he is a scientific staff member of the project »Deutsches Textarchiv« (DTA, www.deutschestextarchiv.de), funded by the German Research Foundation at the Berlin-Brandenburg Academy of Sciences and Humanities. In the context of CLARIN-D (<http://www.clarin-d.de>), he was the coordinator of a curation project for the appraisal and integration of historical text resources of the 15th-19th century into the CLARIN resp. DTA infrastructure (http://www.deutschestextarchiv.de/clarin_kupro).

Since March 1994 Walther Umstätter has been Professor, and repeatedly head of the Institute for Library Science (later on Institute for Library and Information Science) at the Humboldt-University of Berlin. Special topics: Computerization in libraries, modern media, indexing, and classification with modern technology. For some years: member of the editorial board of the journal "Nachrichten für Dokumentation". Vice president of the Society for Science Studies in Berlin, part of the managing committee of the German section of the International Society for Knowledge Organization (ISKO) and cofounder of "Der Förderverein Bibliothek Altlandsberg e. V.
